

## **2021-2022 Special Ed Reporting Quick Tips**

### **BEDS Day Special Ed. Reporting – VR 1-6 & VR 8**

- Source Data for SE Data: Special Ed. System: Frontline IEP / ClearTrack
  - Extract: BEDS Day Snapshot
- Source Data for Student Demographic/Enrollment Data – Student Management System
  - Extract: Student Lite (Demographic) / Student Entry/Exit (Enrollment) / Programs
- Deadline to load data: **Jan 6, 2022** / Deadline to Certify – **January 10, 2022**
- *All districts are required to certify VR 1-6 & VR 8 Reports*

### **End of Year Special Ed. Reporting – VR 11 (Indicator #11), VR 12 (Indicator #12), & VR 14**

- Source Data for SE Data: Special Ed. System: Frontline IEP / ClearTrack
  - Extracts: Special Ed. Events
- Source Data for Student Demographic/Enrollment Data – Student Management System
  - Extract: Student Lite (Demographic) / Student Entry/Exit (Enrollment) / Programs
- Deadline to load Special Ed. Events: **Sept. 15, 2022** / Deadline to Certify – **Sept. 19, 2022**
- Deadline to load student demographic & enrollment data – **August 18, 2022**
- *All districts are required to certify VR 14 Report / Only those districts required to submit federal indicators #11 & #12 for a given year are required to certify VR 11 & VR 12*

### **End of Year Special Ed. Reporting – VR 13, VR 15 (Indicator #7), & VR 16**

- Source Data for SE Data: Special Ed. System: Frontline IEP / ClearTrack
  - Extracts: End of Year Snapshot (VR 13)/ Assessment Fact (VR 15)
- Source Data for Student Demographic/Enrollment Data – Student Management System
  - Extract: Student Lite (Demographic) / Student Entry/Exit (Enrollment) / Programs
- Deadline to Certify – **August 1, 2022**
- *All districts are required to certify VR 13 Report / Only those districts required to submit federal indicator #7 for a given year are required to certify VR 15 / Only districts that used up to 15% of IDEA federal funds to provide CEIS or CCEIS are required to certify VR 16*

### **Data that is reported manually into the PD System**

- PD 6 - Report of Personnel Employed or Contracted to Provide Special Education and Related Services to Students with Disabilities – **Deadline February 1, 2022**
- PD 8 - Report of Students with Disabilities Subject of Disciplinary Removal – **Deadline August 22, 2022**

### **Federal Indicators**

- New York State will collect data for Federal Indicators 7, 8, 11, 12, 13 and 14 from a different group of one sixth (1/6) of the school districts on each indicator each year

- Indicator #7 is reported through VR 15, Indicator #11 through VR 11, and Indicator #12 through VR 12

**\*\*Verification reports 7 and 9 are provider reports that do not require certification\*\***

### **SR Reports are entered directly into the PD Data System under Self Review Checklists**

- SR4 and SRS – deal with suspension rate for SWD (discrepancies and disproportionality) – **Due 1/10/22**
- SR9, SR10A, and SR10B – Deal with disproportionate Representation of Students with Disabilities– **Due 6/10/22**
- SR13 - Secondary Transition IEP Review for Students with Disabilities – **Due 8/29/22**
