
NYSSIS

Workshop Descriptions:

Accountability Review

Attendees will review NYS Accountability Rules currently in effect. We will discuss the most up-to-date rules regarding all students, students with disabilities, and students taking the NYSAA or NYSESLAT exams. Prior knowledge of NYS Accountability is recommended.



BARS

The BOCES Assessment Reporting Software-Attendees will learn how to log in, set school year, access single and multi-year reports, use filters, customize filters, and export data into other applications.

Data Discussions

This workshop is designed for administrators to initiate data discussions among staff members. We will define common assessment terms to help administrators and teachers communicate test results to parents. Real data will be used as a basis to discuss protocol for analyzing data. The goal of this workshop is for participants to feel comfortable facilitating data workshops in their respective buildings.



Score Projection Tool

The Regents Score Projection Program utilizes the results of the Regional Data Analysis and Research conducted by Eastern Suffolk BOCES, Student Data Services, annually. The analysis utilizes historical Suffolk County student data, to project future performance outcomes, for students taking a New York State Regents exam.

Formative Assessments

This workshop will provide an overview of formative assessments and how the results inform your instruction as you teach. Learn how to design formative assessments, collect and track formative assessments and use mobile technology and PowerPoint to give you feedback allowing you to make instant instructional decisions based on real time data. Come join us and discover the basic elements and steps to implement a formative assessment data collection system that informs instruction and builds evidence for your professional portfolio.



L2RPT/Report Net

We will provide hands-on training in the use of this web-based program. Attendees will learn how to navigate through the wide variety of reports available. These reports include demographic, enrollment, and program service data errors, NYSSIS duplicate ID's or missing information, and summaries, verification, program service and student detail reports.

NSC/Customized College Reports

National Student Clearinghouse Customized College Reports help school districts determine:

- How many of their high school graduates enroll in college?
- Student persistence to graduation from college?
- How long it takes for students to get their degree?
- Student attendance to in-state or out-of-state and attendance in 4-year or 2-year schools?
- Which colleges are most commonly attended?
- Percentage of first time to college enrollment over time.
