2022-23 IMPORTANT DATA DEADLINES

OCTOBER 5, 2022 – BEDS DAY

BEDS DAY IS AN ANCHOR DATE USED TO MAKE CERTAIN ACCOUNTABILITY DETERMINATIONS, **IT IS NOT A DATA DEADLINE.** BEDS DAY IS A MARKER TO MEASURE STUDENTS WHO WILL BE OFFICIALLY REFLECTED IN THE L2RPT BEDS DAY REPORTS THAT DISTRICTS WILL EVENTUALLY CERTIFY

2022-23 IMPORTANT DATA DEADLINES

OCTOBER 5, 2022 – BEDS DAY

THREE TIMES DURING THE YEAR, BEDS DAY ENROLLMENT AND FREE AND REDUCED PRICE LUNCH (FRPL) ARE CALCULATED FOR REVIEW AND/OR USED FOR PRELIMINARY STATE AID CALCULATIONS. THE DATES WHERE THESE DATA ARE PULLED ARE AS FOLLOWS:

- JANUARY 6, 2023
- MARCH 17, 2023
- JUNE 30, 2023

2022-23 IMPORTANT DATA DEADLINES

OCTOBER 27, 2022 – AUGUST GRADUATES DUE

LAST DAY TO LOAD AUGUST 2022 GRADUATES FOR THE 2016, 2017, AND 2018
TOTAL COHORTS.

2022-23 IMPORTANT DATA DEADLINES

NOVEMBER 18, 2022 – IMF / BEDS COLLECTION

LAST DAY TO ENTER IMF SCHOOL AND DISTRICT DATA VIA THE IDEX SYSTEM

THE IMF CONTAINS DATA ON EACH SCHOOL DISTRICT, PUBLIC AND PRIVATE SCHOOL, AND BOCES IN NEW YORK STATE. EACH RECORD PROVIDES INFORMATION ON ENROLLMENT STATISTICS, THE NUMBER AND TYPE OF PROFESSIONAL AND PARAPROFESSIONAL STAFF AND LIMITED INFORMATION ON FACILITIES SUCH AS THE NUMBER AND TYPE OF CLASSROOMS AND BUILDINGS. THE SCHOOL AND BOCES DATA RECORDS IDENTIFY SPECIAL EDUCATIONAL PROGRAMS AVAILABLE AT EACH INSTITUTION. PUBLIC AND PRIVATE SCHOOL FACILITIES, EDUCATIONAL RESOURCES, AND THE NUMBER AND TYPE OF STAFF.

2022-23 IMPORTANT DATA DEADLINES

JANUARY 5, 2023 – SPECIAL EDUCATION DATA

LAST DAY TO LOAD SPECIAL EDUCATION BEDS DAY SNAPSHOT, AND
CORRESPONDING PROGRAMS FACT DATA, TO POPULATE VR 1-9 REPORTS. VR
REPORTS MUST BE CERTIFIED IN THE PD SYSTEM BY **JANUARY 9, 2023.**

2022-23 IMPORTANT DATA DEADLINES

MARCH 15, 2023 – UPK ANNUAL ENROLLMENT

COUNTS OF UPK STUDENTS ENROLLED THROUGH **MARCH 15, 2023** ARE COLLECTED FOR CALCULATING UPK GRANT FUNDING. CORRECTIONS CAN BE MADE UP UNTIL FINAL PULL DATE OF **JUNE 2, 2023**.

2022-23 IMPORTANT DATA DEADLINES

MAY 12, 2022 – COURSE INSTRUCTOR ASSIGNMENT, STUDENT CLASS ENTRY EXIT, AND STUDENT DAILY ATTENDANCE

ALL STUDENT COURSE AND ATTENDANCE DATA MUST BE LOADED, AND WILL BE EXTRACTED FROM SIRS ON **MAY 15, 2023**, FOR GROWTH PURPOSES. THE OFFICIAL STATE TEACHER COURSE TO CERTIFICATION MATCH IS BASED ON **MAY 12, 2023** DATA. 2022-23 COURSE AND ATTENDANCE DATA MAY BE UPDATED UNTIL SIRS CLOSES IN AUGUST.

2022-23 IMPORTANT DATA DEADLINES

JUNE 9, 2022 – STUDENT DAILY ATTENDANCE

STUDENT DAILY ATTENDANCE FOR STATE PROVIDED GROWTH RESULTS
ATTENDANCE RECORDS SHOULD INCLUDE INSTRUCTIONAL DAYS THROUGH **MAY**
15, 2023.

2022-23 IMPORTANT DATA DEADLINES

AUGUST 3, 2022 – SPECIAL EDUCATION DATA

LAST DAY TO LOAD SPECIAL EDUCATION END OF YEAR SNAPSHOT, AND CORRESPONDING PROGRAMS FACT DATA, TO POPULATE VR 13, 15 AND 16 REPORTS. VR REPORTS MUST BE CERTIFIED IN THE PD SYSTEM BY **AUGUST 7, 2023.**

2022-23 IMPORTANT DATA DEADLINES

AUGUST 17, 2023 – FINAL SIRS END OF YEAR DATA

ALL SIRS DATA WITH THE EXCEPTION OF STAFF EVALUATION AND SPECIAL ED. EVENTS MUST BE LOADED TO LEVEL 0. DATA SUBMITTED BY THIS DATE WILL BE USED FOR FEDERAL AND STATE REPORTING, STATE AID ALLOCATIONS, AND TO MAKE ACCOUNTABILITY STATUS DETERMINATIONS. ALL DATA NEEDS TO BE CERTIFIED BY **SEPTEMBER 1, 2023.**

2022-23 IMPORTANT DATA DEADLINES

SEPTEMBER 14, 2023 – SPECIAL EDUCATION DATA

LAST DAY TO LOAD SPECIAL EDUCATION EVENTS TO POPULATE VR 11, 12 AND 14 REPORTS. VR REPORTS MUST BE CERTIFIED IN THE PD SYSTEM BY **SEPTEMBER 18, 2023.**

OCTOBER 5, 2023 – AUGUST GRADUATES AND GRADUATION RATE

LAST DAY TO LOAD AUGUST 2023 GRADUATES FOR THE 2017, 2018, AND 2019
TOTAL COHORTS.



2022-23 IMPORTANT DATA DEADLINES

OCTOBER 19, 2023 – STAFF EVALUATION

LAST DAY TO LOAD OVERALL STAFF EVALUATION RATING AND SUBCOMPONENT SCORES. STAFF EVALUATION DATA NEEDS TO BE CERTIFIED IN NYSED'S APPLICATION BUSINESS PORTAL BY **OCTOBER 27, 2023.**
