What is the PD Data System?

(PD stands for Pupils with Disabilities)



The PD Data System is an online tool for the collection, verification and certification of Special Education data. The majority of the data displayed in the PD System is pulled from the Student Information Repository System (SIRS) data warehouse. Additionally, some data is entered directly into the System.

PD Data System Entitlements

- o In order to access the PD system, users must have a State Education Department Delegated Account System (**SEDDAS**) **username and password**. Information on SEDDAS can be found at <http://www.p12.nysed.gov/seddas/seddashome.html>.
- o For the PD Data System, the entitlement is “PD System” and there are up to two specific level of access:
 - PD Contact:** This delegation allows the user full access within the PD Data System. This user can see all data, drill down to student level data, enter data and certify reports within the system.
 - CIO:** This delegation allows **read only** access to all forms within the PD Data System. This user can view all data and drill down for student level data. **They cannot enter data or certify reports.**
- o By default all Superintendents and Charter School Leaders will have “PD Contact” access, which entitles them to full access within the PD Data System and the ability to enter data and certify reports.

Definitions



- **VR**-Verification Reports; any form beginning with a **VR** is reported through SIRS
- **PD**-forms that can only be entered directly in the **PD Data System**-(PD 6 and 8)
- **SR**-Self Review checklists that are entered directly into the PD System



Verification of Data - Verification Button The person named as the PD Contact Person in this data system has the responsibility to certify data in the PD system for each VR report. Therefore, only this person can see and use the PD System verification button ("Click here to confirm your data"). Once the verification has been completed, a message will appear at the bottom of the respective VR report indicating that the data has been verified. This message will be viewable by anyone who has an active access password for that school district.

Verifying Zero Data

If a school district is required to submit data for a VR report for a particular school year, that report will be listed under the school year in the menu bar (navigation bar) above.

A school district that is assigned to report data for a particular VR report for a particular year and has no data to report for that report, is still required to verify that "zero" data are accurate for that report. This verification lets the Department know you don't have any eligible students to report for that particular report; in other words, the zero data are accurate.
